One (1) examination copy has to be produced in the following format:

- printed on both sides // 80 g/m² paper // DIN-A4 format // permanently bound (no spiral binding)
- upload an electronic version in Docata (max. 20 MB)

year of submission. NO Small Capitals in the title.

different) date of print release)1

Sheet 2 Explanation of where and in which period the dissertation has been carried out
